Course Description: This course, examines the origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties, and civil rights.

COURSE EXAMS**

During the semester, there are four scheduled class exams. All exams will be administered online, and each exam is worth 15% of your overall grade. It is imperative that students keep up with class assignments and readings if they wish to succeed in this course. The exam dates are listed in the course calendar (see below). Each exam will cover only the material since the last exam, including both the readings and class discussion.

RESEARCH PAPER

Students will be expected to write a research paper for the class and submit it through Blackboard. The paper must be submitted by 11:59 p.m. Friday, July 2nd, 2021. The paper is worth 20% of your overall grade for the class. Guidelines for the paper will be posted on blackboard.

DISCUSSIONS

Discussions represent the interactive component of this course. Each unit will have one current event question associated with it. These topics are related to the current controversies taking place in American politics today. These forums are a way of exchanging information with your fellow students. There will be 4 discussion questions that I will post throughout the semester online. Each discussion is worth 5 points towards your overall grade in the course. The discussion dates are listed in the course outline. **DO NOT WAIT** until the end of the unit to begin posting. Late posts will not be graded!! Pay close attention to due dates! Follow the discussion guidelines posted in the getting started section of the course.

Make-Up Policy: All assignments are given a due date. If students are absent from class, it is their responsibility to obtain the assignments given in class. Assignments are to be turned in by the due date. If students miss a discussion, they will not be accepted and will be given the grade of 0 (zero). Students who miss exams one, two or three have an opportunity to make up the exam; however, there will be a 30-point deduction. There will be no opportunities to make up exam four if missed; a grade of zero will be given for exam four. Students who miss an exam must contact the instructor to schedule when they are to take the exam. **Please note** that if a student has a valid excuse, then I will allow them to make up missed work without any type of penalty being assessed. Documentation must be provided such as a doctor's note.

All students are expected to be present on test days designated by the instructor. Exams must be taken at their scheduled times and may not be made up later without prior approval of the instructor.

Attendance Policy: If you want to pass, come to class. In an online environment, this means you should sign in multiple times a week and should expect to spend several hours a week in the course reviewing lessons/completing Lesson Modules and completing other course material. The online material goes beyond the material presented in the text, and you will be held accountable for this material on the exams and course assignments. The discussion component of the course also requires you to engage your fellow students in “conversation,” which requires you to regularly read and respond to posts.

Communicating with your instructor: ALL electronic communication with the instructor must be through your COM email. Due to FERPA restrictions, faculty cannot share any information about performance in the class through other electronic means. (Faculty may add additional statement requiring monitoring and communication expectations via Blackboard or other LMS)

Success Tips for Students:

1. Read the syllabus. The syllabus is a critical resource for any course. It is the road map or ‘game plan’ for the entire course—get to know it well. Print a copy on the first day of class, read through it twice.
2. Plan weekly study times. Studying, participating in forums, and completing assignments in an online class can be challenging, even more so when juggling multiple responsibilities. Time management is vital for online students.
3. Log onto the course home a minimum three times per week. Logging onto the course home page consistently each week is associated with higher grades for students according to several studies on online student behavior. Get into the habit of checking in consistently, even daily, to read discussion posts, check for instructor announcements and/or review course materials.
