Late Work, Make-Up, and Extra-Credit Policy: Any late MindTap activities will result in a 10 point deduction for each time it is requested to extend due date. No work will be taken past the class end date. Tests and activities can be made up upon return with a 10 point reduction, (even if taken the next day). It is the student's responsibility to request make up tests and assignments. Extra credit is not available.

**Attendance Policy:** The faculty believes that experiences in the classroom and laboratory cannot be adequately duplicated if a student is absent. In addition, the Skin Care / Cosmetology Programs are designed to teach professional work habits, such as attendance. lecture or lab will result in a dismissal from the scheduled class. Students arriving late (after 5:15pm) or leaving early (before 10:15pm) or before class is dismissed is considered a tardy. IF you are not back at the designated time for break, you will be counted tardy and it will affect your attendance. Any student missing more than an hour of class per day, will be counted absent. Any time past 4 absences, will result in being dropped from the class.

Additionally, HB 1508 authorizes licensing agencies to require reimbursements when a student fails to receive the required notice.

Disclaimers/Additional Policies: Instructors may, at their discretion, withdraw a student due to lack of attendance, or the inability to maintain the prescribed minimum rate of progress (70% test average) stated in the course syllabus.
