Course Description: Anatomy and Physiology I is the first part of a two-course sequence. It is a study of the structure and function of the human body, including cells, tissues, and organs of the following systems: integumentary, skeletal, muscular, nervous, and special senses. Emphasis is on interrelationships among systems and regulation of physiological functions involved in maintaining homeostasis.

Prerequisite: TSIA2 945-990 ELAR/CRC test AND 5 or higher on Essay OR 910-944 on CRC with 5-6 on Diagnostic Test + 5 or higher on Essay, or IRW 0320 with a grade of "C" or better. BIOL 1408 with a grade "C" or better is strongly recommended as a prerequisite but is not required.

Course requirements:

Online Lecture Exams & Comprehensive Final Exam via Brightspace

There are 4 online exams and 1 comprehensive final exam (CFE) online. **Exams are administered in Brightspace/D2L using Respondus Lockdown Browser with Monitor.** Your computer must have a builtin webcam, or you can purchase an attachable webcam. Each lecture exam consists of multiple-choice, fill-in-the-blank, matching, true-false, essay, and identification. Exam dates are listed in the "What's due when/?" document and will be open for **7 days**.

Online Exam Quizzes via Brightspace

There are 4 online exam quizzes in Brightspace. Each quiz consists of multiple-choice questions. You will have 60 minutes to answer the questions. Exam quizzes are assigned the week prior to an exam. The "What's due when/?" document lists exam quiz due dates.

Online Chapter Quizzes via Brightspace:

You will have 13 online chapter quizzes. Due dates are listed in the "What's due when/?" document by 11:59 pm on Saturday.

Online Lab Activity Quizzes (LAQ) via Brightspace

There are 12 online lab activities. Each activity reinforces material found in the 2 scheduled lab practicals. You are responsible for watching all videos uploaded to the Lab Material area for a lab activity. The "what's due when/?" document lists lab quiz due dates.

There are 2 lab practicals administered in the lab. Practical dates are listed in the "What's due when/?" document.

Bonus Points:
