Course Description: This course is designed to develop skills and understanding in the following areas: basic algebra concepts to include exponents, factoring and radicals; relations and functions, inequalities, algebraic expressions, and equations (absolute value, polynomial, radical, rational), with a special emphasis on linear and quadratic expressions and equations.

Prerequisites/co-requisites: Prerequisite of TSIA2 Math Diagnostic 4.

Homework for each section will be completed online using MyMathLab.

Quizzes and Exams:

Four online quizzes will be completed in *MyMathLab*. You can retake each quiz just once to improve your score; the higher score will be the one that counts. There will also be four unit exams and a comprehensive final. No retakes are permitted.

Required Technology:

- MyMathLab software is required for this class.
- A calculator is also required.
- Access to the internet is necessary to complete online homework, quizzes, and test reviews.

Determination of Course Grade: The course will be determined by the following formula:

Final Average = 60%Chapter Exam Average + 20%Final Exam + 10%Homework Average + 10%Quiz Average

- 3. Recognize and use algebraic (field) properties, concepts, procedures (including factoring), and algorithms to combine, transform, and evaluate absolute value, polynomial, radical, and rational expressions.
- 4. Identify and solve absolute value and linear inequalities.
- 5. Model, interpret and justify mathematical ideas and concepts using multiple representations.
- 6. Model, interpret and justify mathematical ideas and concepts sing multiple representations.
- 7. Connect and use multiple strands of mathematics in situations and problems, as well as to the study of other disciplines.
