

HOW TO CALCULATE YOUR GRADE: (Points Earned / Points Possible) X 10 **Example:** You have earned 180 out of 200 possible points so far in the class. - Career Project (Parts 1-5): You will initially choose two potential careers to investigate (Part 1; 25 points), which you will then compare and contrast in an effort to pinpoint one career that is a "best fit" for you (Part 2; 25 points). You will consider the role of social responsibility in your chosen career (Part 3; 25 points) and how you will use the information from each of the textbook chapters to be successful in this career (Part 4; 25 points). Finally, you will prepare an oral/visual (video) presentation to share with your peers (Part 5; 100 points).
- **Discussion Board Posts (15):** For each discussion board post assignment, you will choose ONE of the discussion questions indicated from the chapter to respond to (20 points). You must also submit a reply to at least one other student's post (5 points).

Late Work & Make-Up Policies: If for any reason the college closes, continue to work on the assignments as instructed in your syllabus and on D2L. In the event of illness or emergency, late work may be accepted at a reduced or no penalty at the discretion of the instructor and with documented evidence, *if students contact the instructor as soon as possible (preferably*

before the deadline). Technological issues are not an acceptable excuse for a late assignment. **Late work will NOT be accepted.**

Assignment Submission & Extra Credit Policies: Assignments must be submitted to D2L as .doc/.docx (Word), .pdf, or .jpeg files. It is good practice to double-check after submitting an assignment (resubmit the correct document if needed). It is ultimately your responsibility to submit work in the proper format on time.

Attendance & Classroom Conduct Policies: Although this is an online course, regular "attendance" and participation are critical to being successful. This course is conducted entirely online, which means that you must be diligent about working on assignments to meet the deadlines.

It is expected that everyone treats each other with mutual respect. In an online class, we demonstrate respect to one another by being mindful of the words and tone used in online correspondence (i.e., emails, discussion board). Online discussions in this course may include sensitive topics. It is ok to disagree with others, but it is not ok to verbally attack someone because of their ideas or beliefs.

The material generated by these programs may be inaccurate, incomplete, or otherwise problematic. Beware that use may also stifle your own independent thinking and creativity.

Every submission should be an original composition that the students themselves wholly created for this course unless your instructor specifically states that you may use it in a brainstorming manner on a particular assignment; in which case your instructor may want you to cite what has been Al generated. With the exception noted above, students are not allowed to use any alternative generation tool for any type of submission in this course.

Faculty reserve the right to use Artificial Intelligence (AI) detection software, compare present to past work, or require verbal explanation of your work to find instances of Algenerated writing in student submissions. The findings are binding and can be subject to student code of conduct, academic dishonesty, and plagiarism policies in the course. You will receive a grade of zero on your assignment, will be reported to the Dean of Students, and can ultimately fail the course.
