<u>**Course Description</u>**: Anatomy and Physiology II is the second part of a two-course sequence. It is a study of the structure and function of the human body including the following systems: endocrine, cardiovascular, immune, lymphatic, respiratory, digestive (including nutrition), urinary (including fluid and electrolyte balance), and reproductive (including human development and genetics). Emphasis is on interrelationships among systems and regulation of physiological functions involved in maintaining homeostasis.</u>

Course requirements:

Lecture Exams & Comprehensive Final Exam

There are 4 in-person exams and 1 in-person comprehensive final exam (CFE). Each lecture exam consists of multiple-choice, fill-in-the-blank, matching, true-false, essay, and identification. Exam dates are listed in the "what's due when/?" document.

Online Lecture Quizzes via Brightspace

There are 4 online lecture quizzes in Brightspace. Each quiz consists of 25 to 32 questions. You will have 60 minutes to answer the questions. Lecture quizzes will be assigned the week prior to an exam. Lecture quiz due dates are listed in the "what's due when/?" document.

Mastering A&P Assignments via Brightspace

You will have 10 online assignments in the Modified-Mastering A&P. Due dates are listed in the "what's due when/?" document. **Required online component**, you will access via BB from day one.
