Course Description: Survey of theatre including its history, dramatic works, stage techniques, production procedures, and relation to other art forms. Participation in productions may be required. Prerequisite: Eligible for ENGL 1301. This course fulfills the Fine Arts credit in the core curriculum.

Course requirements: Online activities and discussion, presentations, quizzes, play reviews, and projects as assigned.

Withdrawal Policy: Students may withdraw from this course for any reason prior to the last eligible day for a “W” grade.
