Course Description:

The course provides study of the biological, psychological, and sociological concepts applicable to basic needs of the family including childbearing and neonatal care. Utilization of the nursing process in the assessment and management of the childbearing family. Topics include physiological changes related to pregnancy, fetal development, and nursing care of the family during labor and delivery and the puerperium. Faculty reserve the right to make changes to the syllabus as they deem necessary (Lecture 32, Lab 16 hours, Credit 2, Contact Hours 48, 8-week course).

Prerequisites: VNSG 2331 and VNSG 1261 with a grade of "C" or better. Co-requisites: VNSG 1119, VNSG 1234, VNSG 1432, VNSG 2460.

Course requirements:

- 2. Analyze focused assessment data to prioritize problems that can be addressed by the nurse.
- 3. Assist in the development of the plan of care that identifies patient goals/outcomes and nursing interventions utilizing evidence-based practice and in collaboration with obstetric patients and their newborns from diverse spiritual beliefs and cultural backgrounds, their families, and the health care team.
- 4. Implement the plan of care within legal and ethical parameters in accordance with the scope of practice to provide safe, compassionate, ethical nursing care for obstetric and newborn patients and their families.
- 5. Apply effective communication when implementing teaching plan for obstetric patients, their newborn, and their families.
- 6. Assists in the evaluation of effectiveness of patient goals and related nursing interventions and assists in modification of the plan of care in response to changing patient needs in obstetric and newborn patients.
- 7. Assists in the coordination of human, information, and material resources in providing care for assigned obstetric and newborn patients and their families.
- 8. - 10. Serve as a health care advocate in activities that focus on financial and community resources, improving the safety, quality, and health care of obstetric and newborn patients.

- 9. Explain common nursing responsibilities during the labor and birth.
- 10. Describe the care of the newborn immediately after birth.

- 7. Discuss the advantages and limitations of pharmacological methods of pain management.
- 8. Explain each type of pharmacological pain management including the nursing role for each.

- 16. Discuss the principles of weaning the infant from the breast.
- 17. Describe techniques of formula preparation and feeding.
- 18. Discuss the dietary needs of the lactating mother.
- 19. Review appropriate discharge teaching for the postpartum woman and her newborn.

- 8. Interpret discharge teaching for the mother and her newborn.

- 6. Contrast the techniques for feeding preterm and full-term newborns.
- 7. Discuss two ways to help facilitate maternal-infant bonding for a preterm newborn.
- 8. Describe the family reaction to preterm infants and nursing interventions.
- 9. List three characteristics of the post term infant.

14. The Newborn with a Perinatal Injury or Congenital Malformation

- 1. Define each key term listed.
- 2. List and define the more common disorders of the newborn.
- 3. Describe the classifications of birth defects.
- 4. Describe the symptoms of increased intracranial pressure.
- 5. Outline the nursing care for the newborn with hydrocephalus.
- 6. Discuss the prevention of neural tube anomalies.
- 7. Outline the preoperative and postoperative nursing care of a newborn with spina bifida cystica.
- 8. Differentiate between cleft lip and cleft palate.
- 9. Discuss the early signs of developmental hip dysplasia.
- 10. Discuss the dietary needs of a newborn with phenylketonuria.
- 11. Discuss the care of the newborn with Down syndrome.
- 12. Outline the causes and treatment of hemolytic disease of the newborn (erythroblastosis fetalis).
