## **Course Description:**

This course provides a survey of economic systems, forms of business ownership, and considerations for

running a business. Students will learn various aspects of business, management and leadership functions, organizational considerations, and decision-making processes. Financial topics are introduced including accounting, money and banking, and securities markets. Also included are discussions of business challenges in the legal and regulatory environment, business ethics, social responsibility, and international business. Emphasized is the dynamic role of business in everyday life.

## **Course Requirements:**

The course is divided into four sections. For all tasks, please refer to the Schedule of Activities for due dates, point values, and other information.

#### Tests

Four tests (in BrightSpace) will be covering the chapters in the textbook. Face-to-face students will be administered these tests in the classroom using BrightSpace D2L. A list of the chapters covered by each test is provided in the Schedule of Activities. Each test has 50 questions. Once you have started the test it cannot be stopped and restarted no matter what the circumstance. The test will automatically close at the time shown in the schedule of activities. It is your responsibility to monitor your time while taking the test. Only one attempt will be allowed per test. No retakes are allowed.

#### Quizzes

There are **16 Chapter Quizzes (in BrightSpace)**. You have no time limit on these quizzes, and you are allowed three attempts. Your highest score will be automatically accepted as your grade for that quiz. These quizzes are designed to be a study aid to help you prepare for the tests.

#### **Discussion Board**

An **Ethics Case Study Discussion Board (in BrightSpace)** will be required. You will be given a case study to read and consider. You will prepare your response to the questions posed and then respond to others. **Be sure to use the rubric attached within the course.** 

#### **Projects**

**Project 1: Business Case Study Presentation – Managing Change** 

Format: Presentation (PowerPoint, Google Slides, or narrated video) uploaded to BrightSpace.

#### Task:

Choose a company that has faced a major change or turning point (e.g., Netflix shifting to streaming, Ford's EV strategy, Starbucks' global expansion, LEGO's near bankruptcy and recovery).

- Research the case using at least 3 credible sources (articles, reports, or case studies).
- Create a 7–10 slide presentation that covers:
- Company background.
- The challenge or crisis.
- How management responded.
- What worked, what failed.
- Your recommendations for the future.

**Skills Assessed:** Research, critical thinking, communication, presentation design.

**Deliverable:** Slides uploaded (with speaker notes if not narrated).

#### **Project 2: Strategic Business Plan or Turnaround Paper**

**Format:** Written research paper (4–5 pages, APA citations).

#### Task:

Either create a mini business plan (new product/service idea with market research and management structure)

OR analyze a struggling company and design a turnaround strategy.

**Skills Assessed:** Research, strategic thinking, written communication.

#### **Activity:**

Interview a local **small business owner or manager** about their **marketing strategies and challenges.** Examples of small businesses you might choose include:

- HVAC company or repair service
- Fast food or local restaurant
- Coffee shop or bakery
- Hair salon or barber shop
- Fitness trainer or gym owner
- Auto repair shop or car wash
- Retail store (clothing, gifts, convenience store)
- Landscaping or cleaning service

#### Instructions:

- 1. Arrange and complete a short interview with a small business owner or manager.
- 2. Take a **picture of yourself with the business owner/manager** (with their permission) during or after the interview.

- 3. Ask at least **3–4 focused marketing questions**, such as:
  - o How do you currently reach new customers?
  - o What role does social media play in your marketing?
  - o What's your biggest marketing challenge?
  - o If you had unlimited resources, what would you change about your marketing?
- 4. Write a **1–2 page reflection** (250–400 words) that includes:
  - Summary of what you learned from the interview.
  - Key marketing strategies they use.
  - The main challenges they face.
  - One suggestion, based on our course concepts, that could improve their marketing.
- 5. Upload your reflection **and the photo** to BrightSpace under the **Extra Credit** folder.

#### **Grading (Up to 100 Points):**

#### Photo Evidence (Photo is mandatory but not point-scored separately.)

(Proof of real-world interview, not staged, not ai generated, or made-up)

## **Completed Interview Questions** – 50 points

(All questions answered thoroughly, with direct quotes or paraphrased responses from the owner/manager)

## **Insights & Connection to Marketing Concepts** – 50 points

(Show that you understood the business's strategies/challenges and can tie them to course topics like target markets, promotion, digital tools, etc.)

Only one submission is allowed. This is optional, but it's an excellent opportunity to connect course concepts with real-world businesses in your community.

# **Graded Assignments/Feedback/Gradebook:**

Auto graded exams and quizzes should be available for immediate review by the students. **Manually graded assignments (discussion boards and projects)** will typically be graded and returned within one week from the due date. Feedback, if any, will be listed within the attached rubric. Accepted late work will be returned in a timely manner as instructor's availability allows.
