**Required Textbook:** All reading materials are online for free.

**Course Description:** Intensive study of and practice in the strategies and techniques for developing research-based expository and persuasive texts. Emphasis on effective and ethical rhetorical inquiry, including primary and secondary research methods; critical reading of verbal, visual, and multimedia texts; systematic evaluation, synthesis, and documentation of information sources; and critical thinking about evidence and conclusions.

**Course requirements (including description of any special projects or assignments):** You will have a midterm and a final essay exam as well as 3-5 essays as written assignments. In addition, you will be required to do a research project that will include evaluation of both database and web material.

You will also be required to participate in class discussions (Discussion Board). It is mandatory and necessary that you do so.
