**Required Textbook/Materials:** College Algebra, 5th edition by Beecher, Penna, Bittinger, from Pearson. E-Book via MyMathLab in Brightspace - D2L (No Purchase Necessary). We will be using MyMathLab for all assignments and some assessments.

**Course Description:** College Algebra is an in-depth study and applications of polynomial, rational, exponential, and logarithmic functions, and systems of equations using matrices.

# Course requirements: This is a hybrid class. You will be required to learn some of the material outside of class with the aid of videos, which I will provide.

**HW:** There will be a homework assignment for each section covered, whether in-class or outside of class, to be done online using MyMathLab.

**Quizzes:** There are four quizzes to be done online using MyMathlab. You can retake each quiz just once to improve your score; the higher score will be the one that counts. There may also be occasional in-class quizzes. In-class quizzes cannot be made-up or retaken.

**Exams:** There will be four chapter-exams and a comprehensive final. At least one of the chapter exams will be online. You are expected to show your work and for the on-line test(s) and to turn it in during the next class period. Late work will not be accepted. The penalty for no work shown is 20% per problem. **There are no retakes on any of the exams.** All due dates are on the course outline.

**Determination of Course Grade/Detailed Grading Formula:** Your course grade will be determined by the following formula: 10% HWAvg + 10% QZ Avg + 60% EX Avg + 20% Final EX = Final Avg
