**Course Description**

This class examines the scientific study of human society, including ways in which groups, social institutions, and individuals affect each other. Causes of social stability and social change are explored through the application of various theoretical perspectives, key concepts, and related research methods of sociology. Analysis of social issues in their institutional context may include topics such as social stratification, gender, race/ ethnicity, and deviance.

### **Course Requirements**

- Response Papers: Students will write two papers, each in response to a prompt about material covered in the preceding weeks. Papers will consist of five-to-seven paragraphs, approximately 3-pages altogether in length (1.5- or double-spaced).
- Weekly Quizzes: Students will take seven quizzes that assess comprehension of material from the previous week. Students may use their notes and course materials during the quizzes. The quizzes are comprised almost entirely of multiple-choice questions, although true-or-false and matching questions may appear as well.
- Week 1 Preliminary Work: Students will verify participation before the Census Day, introduce themselves, and articulate interests or inquiries that are able to be informed by sociological scholarship.

### **Late Work and Make-Ups**

#### *Late Response Papers*

Students who do not submit a response paper by the deadline (posted in D2L Brightspace) can submit it late for a 50% reduction in points. A *Complete with Deficiencies* paper, for instance, will receive 10 points instead of 20. A *Complete* paper will receive 15 points instead of 30. An *Incomplete* paper will receive 5 points instead of 10. The last day to submit any late papers (to receive 50% credit) is Friday, May 2.

#### *Quiz Make-Ups*

Quizzes should be completed by the deadline (always 11:59 pm on a Sunday). Late quizzes can be taken for 50% of the points earned on the quiz (e.g., an 8.5 / 10 on a quiz taken after the due date will be recorded as 4.25 / 10). The last day to take late quizzes is Friday, May 2.

### **Early Submissions**

The submission of an assignment is an indication to the instructor that the assignment is ready to be graded. Assignments that are submitted and graded before the due date are not eligible to be resubmitted and/or revised for a higher grade. ### **Communicating with your instructor**

### **The Use of Generative Artificial Intelligence**

Since this course intends to cultivate writing, critical thinking, and analytical skills, all assignments that require writing should be prepared by the student. Students should not have another person or entity do the writing of any substantive portion of an assignment for them; this includes hiring a person or company to write assignments and using artificial intelligence tools like ChatGPT. Doing so is not permitted and will be treated as plagiarism (see “Academic Dishonesty” below).

### **Academic Dishonesty**

Academic dishonesty includes (but is not limited to) cheating on a test / quiz, plagiarizing, stealing or dishonestly accessing the instructor’s materials, and colluding with other students. If you engage in any form of academic dishonesty, disciplinary action will be taken in accordance with the COM Student Handbook and Office of Student Conduct. Plagiarism, at a minimum, will result in a 0 on the plagiarized assignment.

### **Incomplete Grades (The “I” Grade)**

The Incomplete Grade (“I”) is a temporary grade given when a student has experienced unforeseen circumstances beyond the student’s control which results in the student being unable to successfully complete the course within the timeframe of the semester.

Per the COM Course Catalog, an “I” may be assigned only when the following conditions are met:

1. No more than 25% of the points possible in the class are still outstanding.
2. The student is passing the course with a 70% or better.

Exceptions to these circumstances can be made at the discretion of the appropriate instructional dean.

It is the responsibility of the student to request an incomplete grade. If these conditions are met, I will draft an “I Contract Form” to be signed by the student, the instructor (me), the department chair, and the Dean. This form will specify (a) the course requirements (assignments) that must be completed and (b) a due date. On (or before) the specified due date, the student must submit the assignments listed in the contract for the incomplete grade (“I”) to be changed to a permanent grade of A, B, C, D, or F. If the student does not submit the required

assignments by the specified due date, the student will receive a permanent grade consistent with the points the student has earned in the course (See “Determination of Course Grade,” p. 2).

Speaking frankly, incomplete grades are not common in my classes. I understand why they are sometimes necessary and I will grant requests for them when the conditions outlined above are met. However, I’ve found that doing work on time and maintaining communication with me when you encounter difficulties can resolve most of the problems that give rise to requests for incomplete grades.

### **Institutional Policies and Guidelines**

**Grade Appeal Process:** Concerns about the accuracy of grades should first be discussed with the instructor. A request for a change of grade is a formal request and must be made within six months of the grade assignment.
