**Course Description:** Survey of theatre including its history, dramatic works, stage techniques, production procedures, and relation to other art forms. Participation in productions may be required. Prerequisite: Eligible for ENGL 1301. This course fulfills the Fine Arts credit in the core curriculum.

**Course requirements:** Online activities and discussion, presentations, quizzes, play reviews, and projects as assigned.
