**Required Textbook/Materials:** <u>College Algebra</u>, 5th edition by Beecher, Penna, Bittinger, from Pearson. E-Book via MyMathLab in Brightspace - D2L (**No Purchase Necessary**). We will be using MyMathLab for all assignments and some assessments.

**Course Description:** College Algebra is an in-depth study and applications of polynomial, rational, exponential, and logarithmic functions, and systems of equations using matrices.

**Course requirements: HW:** There will be a homework assignment for each section we cover in class to be done online using MyMathLab.

**Quizzes/Exams:** There are four quizzes to be done online using MyMathlab. You can retake each quiz just once to improve your score; the higher score will be the one that counts. There may also be regular in-class quizzes. Inclass quizzes cannot be made-up or retaken. There will be four chapter-exams and a comprehensive final. These will be done in class. There are no retakes on any of the exams. All due dates are on the course outline.

**Determination of Course Grade/Detailed Grading Formula:** The course grade will be determined by the following formula:

10% HWAverage + 10% Quiz Average + 60% Exam Average + 20% Final Exam = Final Average
