**IMPORTANT:** You will need the **student set number** I provide in the Read Me First and my introductory email, along with a **code from Norton** to get to the online quizzes!

You can choose your option; no matter what you will need access to the publisher's Inquizitive site to do the majority of the coursework, especially the quizzes. The 3<sup>rd</sup> option is highly recommended while we are away from campus and you would have to wait on delivery:

- 1. Paperback with access to Inquizitive
- 2. 3-hole punch with access to Inquizitive

# **Course Description:**

This course is designed for students with no previous training in music that wish to explore the meaning and forms of music: classical, romantic, contemporary, jazz, folk, pop. The emphasis is on learning how to listen to and appreciate music. Attendance at three out-of-class concerts required. Out-of-class listening required. May be used for fine art credit.

Benefits: In a nutshell, we will be listening to a variety of great music while developing listening skills and vocabulary for increased understanding and enjoyment. This is an academic class with specific assignments and goals, yet you may very well find it more fun than work – after all, who doesn't love music?

This course will introduce the non music major to (1) musical analysis, (2) a summary of the historical development of European musical heritage, (3) American music, and (4) the world's cultural diversity as seen through music.

#### **COURSE REQUIREMENTS:**

Reading and quiz assignments will be due approximately twice weekly. Don't panic, you can get way ahead and many finish this course early. The chapters are short, and so are the quizzes. Discussions are easy to do, but designed to be thought-provoking and interactive. DO panic if you get behind, and catch up! I am doing something that students told me worked well: if you notice the available dates of the assessments, you will see that they are all open until a specific time during the last week, but please go by the Calendar because even though I do not count off for being late, if you get behind there will be no extensions beyond that final date—and no incompletes for this course.

1. Read your textbook whether hard copy or online. If you are really in a hurry during part of the course, focus on underlined terms and major headings. Be sure to read the biographies along the way! Also, you will really need to *listen* (hey, that's the title of your book!) since even some of the reading quiz questions will make no sense to you otherwise. Three hours per week is often more than sufficient for doing all the coursework, but naturally this varies according to your reading/writing levels and prior music experience.

- 2. When you are ready, take the graded Listening/Reading Quizzes by clicking on the Inquizitive icon at Norton digital (these are like games you play and you can keep going until your score is what you want!!), and try to go by the Calendar schedule. If you get behind, catch up by the final week or you will forfeit grades!
- 3. Complete the online Discussions, including responding to your classmates as directed.
- 4. Attend three concerts and write reports on them. You'll find a section devoted to this project below in your syllabus.

## **Course requirements:**

Students are expected to work through each course module including reading, journal assignments, discussions, quizzes, and module exams. In addition, students will do one paper (concert report) and a group project (groups to be assigned later in the semester.

Important note: You are not allowed to stop and restart the timed assessments. They MUST be completed in a single sitting.

You are allowed two attempts on each of the quizzes and the higher grade is the one your will receive.

All assessments are timed!

- Quizzes are 45 minutes.
- Module exams are 90 minutes.

You are allowed only one attempt on module exams.

Be prepared for technical issues while taking assessments. If you have a problem with blackboard or your internet you need to contact support and/or myself right away. I will help as best I can. Don't start any timed quiz or exam unless you are certain of a good connection. You should never try to take them on your phone.

#### Writing in an academic fashion:

When answering questions, journal prompts, or any other kind of writing assignment, you must write as if I do not know the question.

Do not begin any answers with yes or no. You must thoroughly explain your position and support it with examples or facts.

You must use one of two formats. You may number your answers and separate them with a space or you may indent and use paragraph format. Either is acceptable as long as you follow the previous instructions.

It is important to write in an "academic" fashion. Do not use text speak or any kind of short hand. You must use complete sentences, proper grammar, and punctuation. How you speak to your friends is not how you should write. Think of how something might be written in a text book for a college class.

## Late Work, Make-Up, and Extra-Credit Policy:

You will be allowed 1 late break for 1 journal entry and 1 unit exam (excluding the Unit exam). Your late break allows you to submit your assignment/exam up to 1 week past the original due date with no penalty. It is your responsibility to email me your decision to use a late break.

- Journal Entries: I will take journal entries up to 1 week past the original due date (excluding Journal #15). For each calendar day the assignment is late, you will lose 2 points from your score.
- Unit Exams: For each minute you take over the allotted time, 1 point will be deducted from your score. Late submissions must adhere to the late break policy listed above.

## **Attendance Policy:**

Students at College of the Mainland are expected to attend every session of all classes for which they are registered. Students are not permitted a set number of absences or "cuts." Absences are not

classified as "excused" or "unexcused." It is expected that you will login to your class a minimum of 1-2 times a week. Excessive absences may result in your being dropped from the course.

- 3) Critically evaluate the influence of social, political, technological, and/or cultural ideas on music. (See Communication Skills objective below.)
- 4) Articulate the significance of music as an art form within historical, cultural and social contexts. (See Social Responsibility objective below.)

#### **CORE OBJECTIVES**

This course is part of the core curriculum and therefore satisfies our Creative Arts requirement. The following competencies are part of the core, and are listed below with information on their inclusion and means of assessment in this course as mandated by the state's Coordinating Board:

- 1) Critical Thinking (CT): Required (SLO #1—see above section)
  Assessment of your creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information is done through our final Discussion project in which you are to sum up by giving your rationale for choosing a favorite and least favorite work from the style periods studied during the semester.
- 2) Teamwork: Required (SLO #2) Assessment of your ability to consider different points of view and to work with others effectively to support a shared purpose or goal will be made through our Discussion project on the elements of music in which the class members work together to create effective definitions of the art form.
- 3) Communication Skills: Required (SLO #3)
  Your ability to develop, interpret, and express ideas through written communication is assessed through three concert reports.
- 4) Social Responsibility: Required (SLO #4)
  Intercultural competence, knowledge of civic responsibility, and ability to engage effectively in regional, national, and global communities is assessed on a special Discussion in the Concerts area on concert decorum awareness and how it varies widely according to contexts.

This is a 15-week course. There are V modules and a total of 20 units. You will need to complete 2 units per week, and you will have a module exam due every second week. The module exams are comprehensive to the previous units but there is no comprehensive final.
